# Facility Guidelines Institute (FGI) Requirements for Acoustic Ceiling Panels/Tiles June 20, 2024

Environmental Health & Engineering, Inc. (EH&E) provides this report to Rockfon containing our summary of acoustic ceiling panel/tile (ACP) requirements promulgated by the Facility Guidelines Institute (FGI), an independent, non-profit organization dedicated to developing guidance for the planning, design, and construction of healthcare facilities.

The purpose of this document is to provide a summary and set of tables that serve as a reference for architects, engineers, and others involved in healthcare facility design and construction to determine whether and which type of ACPs are allowed or required in each area of healthcare facilities.

### BACKGROUND

FGI publishes guidelines for the planning, design, and construction of healthcare facilities (the Guidelines). The Guidelines, which are generally updated at four-year intervals, are adopted on a state level and apply to new construction and major renovation. EH&E reviewed and summarized the requirements for ceilings in the Guidelines for hospitals, outpatient facilities, and residential facilities as outlined in FGI's 2018 and 2022 editions (FGI-2018 and FGI-2022). Note that some states currently adopt versions of the Guidelines published prior to FGI-2018, and some states do not adopt or use the Guidelines in any official capacity. Refer to FGI's adoption map.<sup>1</sup> EH&E also reviewed other materials; refer to Appendix A for the research methodology and team.

#### SUMMARY

FGI-2018 and FGI-2022 broadly allow for implementation of ACP lay-in ceilings in most healthcare facility areas. Three classes of ceilings may be implemented in healthcare facilities:

- 1. Lay-in ceilings with ACPs with no minimum weight requirement and an un-gasketed grid.
- 2. Lay-in ceilings with ACPs that weigh a minimum of 1 pound per square foot (lb/sq), and/or a gasketed grid (at least one; both not required).

## 3. Monolithic ceilings.<sup>2</sup>

The design and construction requirements for ceilings in Hospitals, Outpatient Facilities, and Residential Facilities are presented in Appendix B in Tables B.1, B.2, and B.3, respectively. The aim of these tables is to serve as a reference to quickly determine whether and which type of ACPs are allowed or required in each area of healthcare facilities. Facility areas and departments within the table are ordered by approximate total square footage for typical facilities.

Ceiling design and construction requirements for analogous areas across facility types have no difference in ceiling design and construction requirements. For example, lay-in ceilings with ACPs and an un-gasketed grid are allowed in staff and administrative areas; and lay-in ceilings with ACPs that weigh at least 1 lb/sq and/or a gasketed grid are allowed in airborne infection isolation rooms in hospitals, outpatient facilities, and residential facilities alike.

Broadly, the ceiling design and construction required by FGI is determined by the types of procedures for which the space is designed.<sup>3</sup> To reduce the chance of infection, surgically invasive procedures that require an aseptic surgical field are to be performed in spaces with monolithic ceilings. Where less invasive diagnostic and therapeutic procedures are performed, the Guidelines allow lay-in ceilings with ACPs that weigh a minimum of 1 lb/sq and/or a gasketed grid. Most other areas, including public areas and most other patient areas where asepsis is not required, lay-in ceilings with ACPs with no minimum weight requirement, and an un-gasketed grid are allowed.

*Laundry and food preparation areas.* In most areas where lay-in ceilings with ACPs that weigh a minimum of 1 lb/sq are allowed, lay-in ceilings with ACPs with no weight minimum and a gasketed grid are allowed as an alternative. The only exceptions are some laundry areas, and food preparation areas, food supply, and storage rooms *in hospitals only*. In these cases, if lay-in ceilings are implemented, the ACPs must weigh a minimum of 1 lb/sq. Note that this does not apply to those areas in outpatient facilities or residential facilities, where lay-in ceilings with ACPs with no weight minimum and an un-gasketed grid can be implemented in all laundry, food preparation, supply, and storage areas.

*Mechanical, electrical, and communications rooms.* The only areas wherein ceilings are not required in healthcare facilities are service areas (mechanical, electrical, and communications rooms); however, ceilings, including ACP lay-in ceilings, are allowed. For areas of healthcare

facilities outside of service areas that are not specified in their respective tables, ceilings are required. Because there are no ceiling requirements for these areas, ceilings may be lay-in ceilings with ACPs with no minimum weight requirement and an un-gasketed grid.<sup>4</sup>
